BSA Licence Exemption

Following representations by Queensland Division the Building Services Authority has agreed to continue to exempt loss adjusters from the licensing requirements under the Qld Building Services Authority regulation. The regulation is very specific and excludes the following activities from licensing "an inspection, investigation or report for assessment of an insurance claim". Loss adjusters acting outside this exemption are likely to require a BSA licence.

On 28 October, the Victorian Division of AICLA held a very successful half-day seminar with the theme of Construction & Building Insurance and Legal Master Class. One of the Guest Speakers was Steve Nance The Deputy President of AICLA who provided us with an insight to his wide knowledge of Construction Insurance.

Breakfast Meeting

On 6 December, 2002 the Western Australian Division of AICLA held a monthly breakfast seminar for its members. The guest speaker, Snr Sgt Ken Sanderson provided an update on the uses and developments of DNA profiling in Police Investigation following up on his presentation about DNA forensics at the 2001 AICLA Conference held in Perth. Based on the UK experience the gathering of DNA information has been a hugely successful tool in narrowing down suspects with the bulk of crime being committed by 10% of the population. It is unfortunate that the legislation regarding collection and use of DNA varies from state to state as this reduces the ability of the states to share data. Ken did emphasise that DNA is not the be all and end all in placing people at the scene of a crime with fingerprints still being the primary identifier. The analysis of DNA is slow and expensive whereas fingerprints can be analysed within hours.

A prior seminar saw engineer Robin Salter from Robin Salter & Associates gave an up-to-the-minute talk on the effects of fire and water on buildings. He expressed particular concern about the development of slab tilt buildings and the implications to insurers and loss adjusters. Robin gave plenty of examples of the effects fire and water had on buildings including swimming pools.

AICLA Diary Advertisers' Sundowner

There was a last minute rally by loss adjusters to attend this important networking function that is held annually in support of the suppliers that advertise in the AILCA diary. Proceeds from the advertisers are used to finance the running of the WA Division and to subsidise seminars.
