AGREEMENT WITH ANZIIF

A new 5 year agreement was recently signed between ANZIIF and AICLA for the continued delivery of the Diploma in Financial Services (Loss Adjusting).

The diploma course which has been extensively updated to reflect market changes and recent regulatory and legislative changes.

Mark Godfrey said the new diploma represented a major financial commitment by AICLA and ensured that the course remained at the forefront of educational courses available anywhere in the world specifically designed for loss adjusters.

Members aspiring to Chartered Loss Adjuster status need amongst other requirements to complete the diploma. Over 200 subject enrolments have been recorded for the first semester 2003 in the diploma course.

MEMBERS' SURVEY

The Institute recently forwarded to members by email a survey seeking feedback on areas of educational needs and views on a range of other matters. Details of the survey will be collated and the findings published in the next issue of LA News.

IFAA MEETS – HOBART

The International Federation of Adjusting Associations is scheduled to meet in Hobart on 23 April 2003. IFAA president Leo Fluitsma said the meeting was historic as it was the first occasion the IFAA had met outside the UK/Europe. Representatives from the United Kingdom, Europe, South Africa, United States, Japan and Malaysia were expected to attend the meeting.

ASIC SUBMISSION

AICLA has been invited to Australian Securities and Investment Commission (ASIC) to make a submission in respect of claims management practices in Australia. ASIC were particularly interested in the impact on consumers of claims practices and sought our views on the effectiveness of current arrangements. Full details of the institute's submission will be made available once the ASIC report is released. The main thrust of the Institute's submission was that we believe persons representing themselves as loss adjusters and claims intermediaries should have minimum professional qualifications and be certified by an accredited body, which has a tiered membership structure, professional development program and disciplinary process.

PRODUCTIVITY COMMISSION MISS THE MARK

Productivity Commission has released a report on Public Liability Claims Management practices in Australia. The report purports to benchmark practices against world standards however failed to recognises the role played by loss adjusters. The Institute has written to the commissioner pointing out the role played by loss adjusters and offering to assist in correcting this anomaly in the report. 
Joint Seminar

OBITUARY GRAHAM KIDDLE

Died 27th January, 2003 - aged 74 years.

Our friendship lasted more than fifty years but there was little prescience of this during my first meeting of Graham Kiddle. It was during 1952 and I had recently been employed by H. J. Crawford, Assessor, 20 Queen Street, Melbourne. The term Loss Adjuster was not then used. Those in the business were few including Len Gray, G.H. Jackson, Ken Stephens, Hec McLean, Basil Belgrove and Ray Levens. There were others but my memory, I apologise, fails me.

Unexpectedly, one day at the office, I was told someone wished to see me. Graham Kiddle, a little older than I, was shown in. We had not previously met.

On introducing himself he said he had the opportunity of

joining G.H. Jackson, whose office was on the other side of Queen Street, and someone had suggested I might be able to explain to him the esoteric activities of an Assessor. Frankly, I was a bad choice for a Vocational Guidance Consultant simply told me the work meant meeting people and some travel. My few months in the work had not yet revealed the extent of this understatement. However, Graham seemed satisfied and duly joined G.H. Jackson so meeting another lifelong colleague and friend, John Brumley. Our strong association continued until his death.

At that time, fifty years ago, there was no Institute but there were stirrings that some Association should be established. Graham, even as a young tyro, became involved in the movement and eventually closely associated with the formation of The Loss Assessors Institute of Victoria (later to become The Institute of Loss Adjusters of Australia), The Council of Loss Adjusters of Australasia and the subsequent affiliation with The Chartered Institute of Loss Adjusters (U.K.). These, of course, were the precursors of the formation, in 1997 of The Australasian Institute of Chartered Loss Adjusters. Graham was always enthusiastic in Institute affairs. He was a Council member for many years, worked on

committees and was President of the Loss Assessors Institute of Victoria 1973-1975. He was a Fellow of both the I.L.A.A. and C.I.L.A.

After G.H. Jackson, then Jackson and Dethridge, Graham, from 1958-1965, was a partner in the firm of R.S. Levens & Lewis. In 1965 he commenced private practice and so continued for the remainder of his professional career, specialising in Liability Investigations.

Graham retired in 1990 but continued monthly dinners with a group of long-time colleagues. This coterie evolved from dinners after Council meetings and now has existed for about 25 years. The last dinner was during December and Graham was present.

During a eulogy at his funeral Graham was described as a loyal friend, a humourist, a sought after raconteur, the keeper of a famous "black book" of jokes, a willing and longstanding participant in voluntary work and "in essence, a gentleman". Those of us fortunate enough to have known him agree.

NEW ZEALAND

"We are sad to advise that Ray Taylor, a fellow of our Institute and an active member of the New Zealand Division, died suddenly over the holiday period. Ray was foundation member of the Australasian Division of CILA and therefore of AICLA.

Ray was in his fiftieth year of loss adjusting and was a friend and mentor to many within our ranks. He was the manager of the North Shore Branch of GAB Robins. Ray was well known for his sense of humour and ability to reach an amicable solution - even with the most difficult claimant.

We extend our sympathy to his wife Brenda and his two adult children - Murray and Janine."
