FROM THE INSTITUTE PRESIDENT, ANDREW THOMAS

Most individuals and organizations spend time at the beginning of each year reviewing the previous twelve months and setting goals for the year ahead. From my perspective as the Institute President I have reviewed our past year's work and propose a number of objectives that, with the support of the Board and our members, I believe are achievable in 2005.

I see the broad objectives of AICLA and ICT as providing education, accreditation and representation for those involved in the loss adjusting and claims industry respectively.

In respect of education and accreditation, the Diploma of Financial Services (Loss Adjusting) the copyright of which is owned by AICLA and delivered by ANZIIF, is regarded as world's best practice in respect of loss adjuster's education and training. I hope in time that the new and highly innovative ICT claims technician course now available through NIBA will also come to be recognised as the standard course for all others involved in claims handling.

It is now a high priority to develop and deliver a convenient, effective and economical on-line continuing professional development (CPD) resource. This project is particularly important as many members find it increasingly difficult to attend seminars and conventions. However, they recognise the importance of maintaining and developing their professional expertise.

Following a number of gradually declining years, membership has grown modestly in the last 2 years. In the seven months since 1 July 2004, 48 adjusters have joined, and we welcomed 30 new members in the previous 12 months to our base of around 900 members. A number of initiatives have seen Australia and New Zealand numbers stabilise and most divisions showing recent growth. Membership growth in Asia continues to be robust with a very energetic division committee having elected representatives in Malaysia, Singapore, Hong Kong and Thailand. We see this growth continuing in 2005 with some exciting prospects in China and other pacific region countries. Membership of AICLA and ICT will be promoted to eligible staff of adjusters, insurers and others via Division Councils and direct company marketing.

I recognise the importance of providing value-add to you, our members. In this regard a considerable amount of the Institute's resources have been expended on the loss adjusting Diploma course, establishing ICT and the claims technician's course. As mentioned, the planned CPD on-line facilities will benefit members. I will be looking to develop an industry benchmarking survey, which is long overdue and will help give each of us a better understanding of our industry. With consolidation of the insurance industry including the loss adjusting sector, some 50% of AICLA members are employed in the four major loss adjusting firms. The board has established a committee to look at the current structure of the Institute and the possibility of corporate membership in complement to our current individual member basis. The claims convention continues to grow and is an important event at showcasing the expertise of loss adjusters to the broader claims industry.

Through the International Federation of Adjusting Associations, of which AICLA is a founding member, work is being finalised on global accreditation for all practising loss adjusters.

Representation is an important role for the Institute and you would be aware of our submission to ICA on the General Insurance Code of Practice. Our discussions with ICA will be continuing over the coming months. The Institute also has well-established relationships with other industry bodies including ANZIIF, NIBA, ARIMA, IDRO, EQC, IOS, AILA and IFAA. At Board and Division level we will be promoting closer liaison with these groups to ensure that the interests of our members are represented.

I look forward to reviewing how we progress against our stated objectives in twelve months time and would welcome any feedback you personally may have on these goals and my vision for our organisation.

ICT COMMITTEE ESTABLISHED

CLAIMS CONVENTION

The committee has finalised the program for the 2005 Australasian Claims Convention to be held at Manly, Sydney 4-6 May 2005. DIPLOMA STUDY COURSE

ANZIIF has replaced the former "Semester" enrolments and "Examination on Demand" enrolments with a single periodic enrolment system, which offers students flexibility to select a study period that suits their needs. Under the new arrangements all students will be required to complete an assignment (30%) as well as the final examination (70%). Students can select a Standard (15 week) study period or a Fast Track (10 week) study period. There are 11 enrolment dates over 12 months under the Standard study and 9 enrolment dates for Fast Track study. - 75 homes totally destroyed
- 26 homes extensively damaged
- 1,600 km of fencing destroyed
- 130 cars destroyed
- 130 items of farming plant and machinery damaged
- 324 sheds destroyed.

The adjusting community responded in an exemplary manner and liaison continues with the ICA and government authorities.
