# FROM THE INSTITUTE PRESIDENT, ANDREW THOMAS

I would like to pay tribute to the large number of members (somewhere in the order of 150 loss adjusters) who have been involved in the aftermath of cyclone Larry that devastated the far North Queensland areas of Innisfail, Babinda and the Atherton Tablelands. Many loss adjusters from throughout Australia and New Zealand have been involved and will continue to be for many months in what is a major disaster. Conditions in the area are very difficult with loss adjusters working long hours in demanding conditions. A lack of electricity, heavy rain and shortages of accommodation and skilled tradesmen are hampering recovery efforts.

A report by the Institute Administrative Officer, Tony Libke on the meeting between insurance industry representatives and the Recovery Taskforce was recently emailed to members. I have asked Tony to keep all members updated on developments. We will also be in contact with Chris Henri of the Insurance Industry Disaster Organisation (IDRO) on matters relating to loss adjusters.

#### VISIT TO ASIA

In the last week of March Ian McWalter, International Development Director and I visited the International Division members. Lunch meetings were organised in Singapore, Kuala Lumpur and Hong Kong, at which both Ian and I spoke to and received feedback from the members present. We also made visits to the MDs of the largest 4 companies in each of those cities, and even managed to fit in meetings with some regional directors, regulators, Insurance Institutes and Colleges of Insurance. We were surprised to tally up our meetings after 4 days at 24 in total, at which we discussed AICLA's involvement in the region with in excess of 70 loss adjusters and insurance industry leaders. I was particularly buoyed by the comments made to us that the managers and trainees both recognized the AICLA Diploma as a professionally produced structured course which is well able to equip adjusters with the technical and soft skills they need to

excel in their jobs. Many were interested to learn about the on-line CPD program and the new 4 paper practicing certificate. I am confident that membership in the region will continue to grow and would not be surprised to see it double again in the next two or three years, as it has done in the last two. We also hope to run local 'masterclass' type seminars in all 3 of these regional Asian cities in 2007. Ian and I would like to pass our sincere thanks to Stephen Kwang (Singapore), James Ong (International Division Chair - Kuala Lumpur), Paul Lam (Hong Kong) and their respective committees for organising the member functions and availing us of their time and local knowledge.
