FROM THE INSTITUTE PRESIDENT, **STEPHEN THORPE**

The Victorian division hosted a successful seminar meeting and dinner on Wednesday 14 March 2007. Tony Libke and I were invited to participate in a meeting with the Victorian Division Committee and the seminar. The guest speaker was Bart Harold - National Claims Manager (Marine) - CGU. Bart spoke from a client's perspective of our profession - and the unique skill set we bring to the claims process.

I spoke on the need to continually improve professionalism, and to this end I am pleased to see the Victorian Division support the proposed new increase in minimum standards. Tony provided members with an update on a number of issues including CPD online, impact of proposed minimum standards on existing members and Recognition of Prior Learning services.

Mr Ian McWalter, as International Development Director, and I spent the last week of March in Malaysia and Hong Kong. In Malaysia we had constructive meetings with the Association of Malaysian Loss Adjusters (AMLA), the Malaysian Insurance Institute (MII), and members generally. With AMLA and the MII we hope to be able to assist in localising one of two of the Intermediate MII exams and with transition through to the Diploma of Loss Adjusting. Ian also provided an outline to members of the, at times, complex cross credits between the MII and the AICLA examination process.

Also with MII, AMLA and members we have agreed a framework for the short seminar series which have been such a success in both South Australia and Queensland.

The Hong Kong visit included a meeting with the CEO's of the major adjusting firms working in the region.

In the same way as the equivalent CEO's meeting in Australia, these forums are an excellent opportunity to both promote the institute to the senior managers who employ over 50% of our members, and to listen to their input and suggestions. Our education system was widely applauded, and it was pleasing to note the support for our education system by both members and senior management. Our new CPD on line also received positive comment. This is credit to the Education Committees over many years.

The education system is not perfect and suggestions made by both groups through out the region have been noted and will be investigated as part of our continuous improvement.

We hosted a luncheon for AICLA members in Hong Kong which was well attended.

Ian and I were also invited to attend two claims industry functions while in Hong Kong. The first was hosted by Clyde & Co (an international firm of solicitors) and was titled "Regional Insurance and Reinsurance Claims Conference". Attending were senior representatives of insurers, brokers and adjusters from the Asia region. The speakers were generally supportive of the role of adjusters in the region and quality rather than fees was, fortunately, the emphasis. Commerciality rather than process and particularly from a reinsurers perspective the importance of a clear, concise report was continually restated.

The second function was Munich Re's review of claims procedures in regard to both one off major and complex losses and catastrophe response. This review included senior Munich Re personnel from both the region and Munich, along with senior adjusters from North and South East Asia, Australia and Europe. AICLA was the only professional body invited to attend. It is anticipated that a "protocol" will emerge as part of the meetings and I will provide details in subsequent editions of LA News
