FROM THE INSTITUTE PRESIDENT, STEPHEN THORPE

AICLA has three core objectives – education, accreditation and promotion. With AICLA being a member of the International Federation of Adjusting Associations (IFAA) which has reviewed industry "**best practice**"; IFAA has acknowledged that AICLA's education system for adjusters is world class. This is a fine tribute to the present and former education directors, their committees and of course our education partner – ANZIIF. Last year our membership structure was improved – all new members are now "**Provisional**" and the reinstatement of "**Affiliate**" level which fills the gap between "Ordinary" and "Associate".

This leaves "**Promotion**". I hasten to add that promotion and advocacy is very different. We need to consider loss adjusters value proposition to insurers and the broader insurance market and given the aging demographic of our membership to a new generation of adjusters. We also need to consider AICLA's own value proposition to members, employers and various other stakeholders.

We have taken two positive steps to enhance this third element. The first is a membership pack titled " **A Career in Loss Adjusting**". For the first time all information about AICLA will be in one place. This will include information on what a loss adjuster is, the role of AICLA, membership pathway, membership structure, our Charter of Objects and Professional Conduct, details on recognition of prior learning, and a diploma course brochure setting out details on each of the 11 diploma modules. These packs will be made available to division chairs – please contact them, a member of their committee, or the secretariat.

The second step is working with an external consultant to help the executive and Board develop an overall promotional strategy. Mr Philip McGuire – ex Deputy CEO of the ICA has been engaged as AICLA's consultant. Details will be circulated following reviews by the executive and Board.

All of the Directors sitting on the Board do so in a voluntary capacity, usually for terms of 2-3 years. The continuity of the ongoing dialogue with allied professional associations (in Australia, New Zealand and Asia) should rest with our Administrative Officer – Tony Libke. As part of consolidating that process, Tony travelled to Singapore and Malaysia with International Director, Mr Ian McWalter. Their report appears elsewhere in this issue.

The New Zealand division held its annual education seminar in Wellington in early May 2008. Speakers were from various disciplines and provided a quality, informative and educational seminar for the NZ members. Congratulations are extended to Division Chair – Mr Graham Smith, Division Secretary – Mr Bruce Weeds and the entire committee.
