FROM THE INSTITUTE PRESIDENT, IAN MCWALTER

This being my last newsletter I sought to find a suitable analogy to start with. Cricketer Don Bradman's last stand in 1948 when in his final test match in England he was bowled for a duck came to mind. The stunned silence of the crowd was similar in nature, I thought, to the response after each editorial I write for LA News.

It took me a year to believe what previous presidents of AICLA had told me: mostly, the only time you ever hear from anyone, in writing, is if you do something wrong. I can now happily report the silence during my two year term has been, on balance, like my predecessors — overwhelmingly deafening!

It is about being able to express oneself, to communicate, to be creative, to be able to help other people and also allow oneself to be helped, in whatever form it is offered. It is to form lasting and strong relationships.

It is not too big a thing to say, as a loss adjuster, it is a role that can allow us to express our humanity in very positive ways. Sure we all have bad hair days, perhaps me more so than most (!), but at the end, if we allow ourselves to, we can be transformed and in so doing transform the lives of others.

Sometimes, as I have found, the things we look for are the things we take for granted, the things that are right under our very noses. Let none of us think that our Institute exists in a vacuum; it exists because each and every one of you takes the time to become a member, sit the exams and become engaged with your fellow loss adjusters.

So to all who make up the Institute, the various division committees, the current board members, our secretary Tony Libke and his team and to you the members, I am indebted to you all for the opportunity to have served, to have given voice and action to some of my ideas and those of many, many others.

I leave the role not with any sense of sadness or unfulfilled ambitions but with a sense of purpose and understanding, a sense that life is very much what we make of it and if we look and listen for the positives we will find them.

In concluding I wish every success to the new incoming board and our new President Ian Lavin. I am sure together they will carry AICLA's legacy proudly and that it will continue to serve well the interests of the members.
