FROM THE INSTITUTE PRESIDENT, MICHAEL COOKE

I have had the great pleasure of attending AICLA End of Year functions in Sydney, Melbourne, Hobart and Launceston in the past month. I thank those Divisions for their invitations and the opportunities they presented me to meet and speak with members.

I noticed at the very start of my career in the Insurance industry that there was a social environment. I attended in those early days insurance industry gatherings, be they company functions or larger meetings and there was always a spirit of goodwill and fellowship apparent among members.

I am privileged in that I belong to other organisations where fellowship is the essential criteria for the continued existence of those organisations and I find it is a welcome haven that I eagerly anticipate when I attend these gatherings to talk with friends and enjoy the respite from what can be at times (in our industry) a very stressful job.

I mentioned in a previous report that we would be outlining initiatives planned for 2013. I am now very pleased to announce a new AICLA award the Carey Bird Scholarship. This scholarship honours a member who lost his life while performing his duties as a loss adjuster and is a reminder to all of the dangers faced by members as they go about often difficult and at times dangerous duties. Details are outlined in this issue of LA News and I encourage eligible members to take the challenge and apply for the scholarship.

The Asian Claims Convention flyer has been forwarded and I urge you to support this event either by your personal participation or by promoting the event to your colleagues for their participation. The convention will be highly educational as evident from the flyer.

Our chief executive Tony Libke and I have been working on proposed amendments to the General Insurance Code of Practice. It is AICLA's view that there should be some changes made to COP to distinguish between Loss Adjusters and Assessors and a requirement for Loss Adjusters to have specified minimum education and training. It is hoped that such a move will go a long way to identifying our members as professionals within the Industry.

I can now report that the cost for members enrolling in modules in the Diploma of Loss Adjusting will reduce significantly in 2013. This reduction was achieved following negotiations with ANZIIF. In Asia where the cost of the modules coupled with the strengthening Australian dollar has stymied growth in recent years the new price is more than 40% lower than in 2012. Full details of costs are outlined in the newsletter.

I would like to wish you and your loved ones a very happy and safe Christmas and a healthy and prosperous New Year.

CAREY BIRD SCHOLARSHIP

As mentioned in the President's report AICLA is introducing a new annual scholarship in honour of Carey Bird an AICLA member who was tragically killed in the Christchurch NZ earthquake on 22 February 2011. Carey was originally from New Zealand but had settled with his wife and children in Sydney. Carey was working on business interruption claims for an international broker at the time of the second major earthquake which resulted in many deaths. His father is Don Bird, life member and brother, Grant Bird a member of the New Zealand Division.

The Board of AICLA initiated the scholarship following discussions with the family.

The features of the award are as follows:

- Open to AICLA members up to age 40 and other members who are over age 40 who at the time of entry are completing modules in the ANZIIF Diploma of Loss Adjusting.
- Written submission a min 1500-max 3000 words
- Topic 2012:

Report on reinstatement of a major structural fire loss, involving a steel frame, galvanised iron warehouse, with concrete slab. The building has galvanised iron sides and roof. Electricity is connected to the building and was upgraded 15 years ago. The building is 70 years old and in "fair condition", rust is present in some of the iron, however minimal.

You are required to outline in your essay, how you would plan your adjustment of this loss, based on total reinstatement compared with indemnity. In your answer you are required to refer to case law precedent base on indemnity. Take into account the conditions and requirements of reinstatement and replacement clauses including extra cost.

For the purpose of this assignment, use ISR MKIV wording.

The winner of the scholarship will be entitled to:

- A framed certificate;
- attendance at the Claims Convention (Sydney) or the Asian Claims Convention with the winner free to select.; and
- airfares, accommodation, meals and out of pocket expenses associated with attendance at the convention.

DIPLOMA COSTS

Under the new contract with ANZIIF the cost of Diploma of Loss Adjusting modules will be significantly reduced for members from January 2013. The new module pricing for AICLA Australian members is \$800, NZ members NZD\$835 and overseas/Asia members AUD \$550. There is also a special rate of \$400/module that applies in respect of members in Indonesia, Phillippines and India. These new costings apply to AICLA members (non members pay a higher cost) and make the diploma more affordable particularly in Asian countries where costs had been impacting enrolments.

COP SUBMISSION

AICLA is finalising a submission to the General Insurance Code of Practice (COP) Reviewer. AICLA is seeking to have the terms, "Loss Adjusters" and "Assessors" defined separately in the revised COP. We also believe it is appropriate that minimum education and training standards be promulgated in the code. In this regard we are seeking loss adjusters to meet the affiliate membership qualification (complete 4 modules in the diploma of loss adjusting) and satisfy requirements under a relevant CPD program.



The brochure for the Asian Claims Convention to be held in Bangkok on 21-22 March 2013 has been released and a copy is also available at **www.aicla.org**. The key note speaker Dr Jonathan Barnett was a member of the small team that was tasked with undertaking the initial investigation of the 9/11 disaster in New York. The presentation is outstanding and involves an in depth analysis of the investigation following the event. Jonathan was previously a professor at Worcester Polytechnic Institute in Massachusetts for 28 years where he taught fire engineering and mechanical engineering. He has also spent time lecturing at the University of Canterbury NZ and did research with CSIRO in Australia. The convention has an excellent line up of speakers covering a wide range of topics. We believe the Bangkok convention will build on the success of the initial ACC held in Shanghai in 2012.

ON-LINE CONTINUING PROFESSIONAL DEVELOPMENT (CPD)

CLIMATE VARIABILITY AND EL NINO

Climate change remains an extremely topical issue, the debate itself getting more heated, with one extreme claiming that the whole thing is an overreaction with political or commercial motives and the other extreme saying that the sea level will rise a matter of metres in a few years. Confusing to the meteorological layperson is the fact that some of the loudest proponents on both sides have no meteorological qualifications. In between we have varying opinions, one being that climate change is a reality of nature that has continued unabated during the history of the World and is completely unaffected by human activity.

We are not about to buy into any of those well-aired arguments. What we are doing at paper CPD047 is looking at a long term weather phenomenon known as El Nino and its opposite counterpart La Nina. Based on the original work of Sir Gilbert Walker in the early part of last century, the Southern Oscillation has been carefully observed and well researched.

We are grateful to the Bureau of Meteorology for permission to publish one of its short papers on the subject, which takes us from the Spanish 'boy-child' that gives the phenomenon its name to the present day and its effect on rainfall (and thus many claims) in particular. Did you already know all about it? Have a look at the paper and see!

We created the on-line CPD facility to provide another alternative in response to submissions that out-of-town adjusters were somewhat disadvantaged in accumulating the necessary CPD points. Here is a facility available at all hours on the night and day, wherever there is internet connection. And of course it is available to all members.

INTERNATIONAL

International Directors trip to the Middle East and London AICLA's International Development Director (IDD), Jaye Kumar, has just returned from a trip to the Middle East. The trip was the culmination of 12 months of preparation and sponsored by Mr Walid Jishi, Regional Director of VRS ALA, the largest loss adjusting company in the Middle East with offices in 13 countries in the region.

Mr Jishi who has set up the ALA Academy in Dubai, an Insurance Training College, had arranged for Jaye to meet

with insurance industry members (loss adjusters, Insurers, Brokers and Regulators) in Dubai, Oman and Jordan. The purpose of the 10 day visit was to promote training and professional development of insurance claims professionals (claims officers) and adjusters through AICLA's Claims Technicians Course (CTC) and Diploma of Loss Adjusting. Presentations were held in Dubai, Muscat and Amman, where loss adjusters were provided with information about the Diploma of Loss Adjusting course, membership of AICLA and the opportunities and benefits of becoming members of an institute of qualified and professionally trained loss adjusters. Insurance and broking company claims executives and staff attending were provided information and advice on the CTC. The presentations were well attended by members of the insurance industry and there was overwhelming support and endorsement from the Insurance Regulators who welcomed the educational and training initiatives by ALA Academy and AICLA.

From the Middle East, Jaye Kumar travelled on to London to meet with FUEDI (Federation of Adjusting Associations in Europe) Executive Committee Member, Kieran Rigby. The meeting was arranged by FUEDI Education Director, Martin Schörkhuber, to discuss how the Diploma in Loss Adjusting course could be offered as a suitable loss adjusting course to their FUEDI members. According the Jaye Kumar "the offering of the ANZIIF Diploma to FUEDI members was not meant to replace any of the courses currently available to FUEDI members nor was any such offering meant to allow bi lateral membership arrangements for AICLA and FUEDI members". He went on to state that," the focus was more on providing assistance in professional training and offering the opportunities for FUEDI members who complete the ANZIIF Diploma of Loss Adjusting to join AICLA as an Associate Member and use the title of Chartered Loss Adjuster".

Jaye Kumar is also finalising arrangements with our industry partners in Indonesia, APKAI (Indonesian Loss Adjusting Institute) and AICLA representatives there, Mr Budi Maharesi and Mr Johari Subianto to roll out the CTC in Indonesia in the first quarter of 2013.
