ON-LINE CONTINUING PROFESSIONAL DEVELOPMENT (CPD)

NEGLIGENCE AND VICARIOUS LIABILITY

Like all potentially long-tail cases, those that centre around liability can be challenging. This is more complicated where an insured entity is deemed responsible for the action of some other person, ranging from employees (relatively straightforward) to the more difficult concept of contractors (often anything but straightforward). In the latter case, the law has shown that the degree of control exercised by the insured and the degree of independence exercised by the wrongdoer are both critical elements and central to the case.

In CPD 051 we look at this issue in some depth and explore the contrasting cases of Stevens v Brodribb Sawmilling Company Pty Ltd [1986], Hollis v Vabu Pty Ltd [2001] and Sweeney v Boylan Nominees Pty Ltd [2006]. All these cases went to appeal as far as the High Court (and even then there were some dissenting findings), and it is instructive to note how the finding of the various courts differed and how the element of precedent was dealt with.

Although the involvement of adjusters in legal cases is usually limited to the preliminary gathering of facts and reporting (with safeguards) to the insurers' legal representatives, most of us are interested in the final — and sometimes surprising — outcome of these cases.
