FROM THE INSTITUTE PRESIDENT, MICHAEL COOKE

Last month's LA News was a bumper edition and I apologise to those visually challenged (of which I am one) who may have had difficulty reading my report on activities.

This month I have been involved in a range of meetings including finalising arrangements for CC14. The Claims Convention in Sydney is the major claims conference in Australasia and attracts a wide audience including loss adjusters, insurers, brokers and others involved in the industry. This year the event is a few day before the Bledisloe Cup in Sydney, something which has already been spoken about by our New Zealand colleagues. Keep the dates 13-14 August clear so you do not miss out on this important event.

A Directors' meeting was held in Melbourne at the start of May and was preceded by an Education and Membership meeting. Some important issues discussed at these meetings were; the sustained uptake in membership in recent months as well as an increased number of enrolments in the Diploma of Loss Adjusting course, both pleasing statistics; we now have two educational workshop packages available for divisions to present to members; a DVD will be produced on Loss Adjusting that will be made available to the Divisions for promotional purposes of AICLA and loss adjusting in general. It will also be available on our website for easy access; the women in loss adjusting project; and the "History of Loss Adjusting "in our region is advancing with the CE Tony Libke interviewing prospective candidates to undertake the writing.

The New Zealand Division held their annual conference and AGM on 23-24 May in Wellington. Tony and I attended both events which were extremely well supported by members, with approximately 40 attending the conference

The New Zealand conference was well run with educational topics and social activities balancing out the two days and giving the delegates the opportunity to learn, socialise and network with AICLA and industry participants. Again my congratulations to Leon Briggs and his Division for a well organised programme. I would also like to take this opportunity to congratulate the New Zealand members who nominated at the AGM for Council in the coming year, both those standing again as well as new members.

ON-LINE CONTINUING PROFESSIONAL DEVELOPMENT (CPD)

THE COSTA CONCORDIA DISASTER

The Costa Concordia disaster of January 2012, when a modern cruise liner sailed far too near to the Island of Giglio and was grounded on rocks, is unusual in origin and bizarre in the way it played out, as well as huge in terms of insured and uninsured risk. It is unlikely that many of our members will have ever had to update that vital first reserve notification from A\$1 billion to A\$2 billion (which would no doubt be to the intense reaction of insurers!); unlikely that deductibles of \$30 million and \$10 million would be reporting elements; and unusual that an Insured is left with \$90 million in other uninsured loss.

In paper CPD060 we explore this extraordinary marine event and its catalogue of errors, some of which would be the subject of some mirth if it were not for the loss of life and other suffering. We start from the simple fact that building bigger and ever bigger ships for economic reasons is itself a part recipe for disaster and will inevitably lead to great salvage difficulties and losses when there are accidental events. Then there is an absence of safety supervision systems that might have led to the prevention of the 'showing off' manoeuvre that is said to have caused the accident. Add the complication presented by a multilingual ship's crew attempting to advise a panicking multilingual passenger complement on safety procedures while confused orders were issued from the bridge, and the potential for pandemonium can only be imagined.

It is said that at an early stage in the rescue, when the captain is alleged to have prematurely left his ship, he was instructed by authorities on shore to 'Get the <extreme expletive> back to the ship!'. Islanders on Giglio later proudly displayed T shirts on which were emblazoned the words 'Get the <extreme expletive> back to the ship!'.

Salvage has been a major exercise, owing to demands from the authorities that environmental considerations should be the primary concern. For example, the complex and hugely expensive operations, which include the building of a special platform on which to perch the righted vessel, have been hampered by the necessity to avoid troubling the sensitive eardrums of dolphins.
